### Citizens on Patrol

Protecting Our Neighbourhood

As residents of the McDonald Lake Subdivision, we are aware there have been a number of break-ins and incidents of vandalism to some homes in the area. At the last MLRA meeting some residents expressed an interest in a Neighbourhood Watch Program. There is such a program in the Prospect area called Citizens on Patrol (COP). This is a program where ordinary citizens supplement police patrols to help reduce crime by keeping a neighbourly watch over their communities. The role of Citizens on Patrol is to simply observe, make notes and report to RCMP. All volunteer patrollers have official photo ID cards, receive training and log in with the RCMP when on patrol. There are several C.O.P. signs along the Prospect Road, indicating the presence of a concerned citizens' task force.

In addition, at the April 11<sup>th</sup> meeting to understand what is important to McDonald Lake residents all members had an opportunity to write down things they would like to see for the community or any concerns that they may have had. The suggestions were:

- 1. Develop park lot on Prospect River Ct. or Nickels Lake. Concern that Prospect River Ct parkland floods. Would also like playground to be developed with parkland.
- 2. Develop a sign for the subdivision and remove the old sign.
- 3. Build a tennis court
- 4. Pave all roads.
- 5. Access to lakes ( Fiddle, McDonald, Nickels) through Park ?
- 6. Concern about power boats on lakes . (ordinance 158)
- 7. Issue of owner's not cleaning up after their dogs. Also, dogs roaming at night. No leash etc.
- 8. Organizing a spring clean-up of community. (ditches etc.)
- 9. Residents wanting to help to develop parkland-clean-up and construction.
- 10. Interest in a neighbourhood watch program.
- 11. Residents willing to help with web site.
- 12. Maintaining peace and quiet.
- 13. Having a shelter built over the mailboxes and a spot to post information for residents.

This is an ambitious agenda! This newsletter, in conjuction with our website, will be the source of information on the status of these issues and projects. It is the voice of our neighbourhood, so bring forward your ideas, articles and concerns, and we'll print them here.

## Paving Update for Subdivision

When I purchased my home in the MacDonald Lake Subdivision last year, my realtor told me the streets would be paved in the next year or so. This February, I contacted the HRM to find out when construction would start and how much it would cost.

The process for paving is a long one. Anne Reid, Roads Paving Clerk for HRM, indicates the first step is to get all residents on the street to register their position (for or against). This is now done through a survey (used to be done through a petition). If the majority of residents want to have their roads paved, the street will go on the waiting list for paving. If streets go on the list this year, they will be paved approximately 7 to 10 years from now. No bill for paving will be sent out until 30 days after paving is completed. The bill can be paid over a decade and cost should not be more than about \$30 per linear foot of frontage (persons on corner lots will pay 50% of what others pay because they will be billed for both streets when paved). For example, 260' frontage x 30/ft = 7800 paid over 10 yrs (\$780/yr). Should all residents want paving, it will not be started for approximately seven years and no bill will come out until that time.

Here is the paving status of the streets in the MacDonald Lake Subdivision:

- Park Court: Being paved soon (announced at the MRLA General Meeting that it would be this summer)
- Sunset Court: Was petitioned in January 2003 and is now on the list to be paved. The HRM is working on the roads petitioned in 2000. However, the HRM will only get to two of the roads petitioned in 2000. Expect three or more years before Sunset Court is paved (unless there is additional funding from the Province or HRM).
- Forest Glade Drive: Survey was sent out April 2005, to have been returned by 16 May. As of 12 May there were not been enough returns to make a decision on street paving. Streets must pass the survey phase to be considered for paving.

The Prospect Road and Area Recreation Association meets every first Monday of the month (except July and August) at the Prospect Elementary School at 7:00pm. Representatives from community groups and organizations are welcomed. Currently, the Association is assisting HRM in recruiting a Steering Committee in the development of an indoor recreation facility for the community. The Steering Committee will consist of 6 community members, 3 youth from the community, and 3 members from the Recreation Association. Also, on the application there is an opportunity to apply for many different sub-committee positions.
